

## 女川原子力発電所の状況（平成28年1月分）

女川原子力発電所は1号機および3号機が通常運転中、2号機が原子炉起動中のところ、平成23年3月11日14時46分に発生した東北地方太平洋沖地震により全号機の原子炉が設計どおり自動停止しました。

（平成23年3月11日お知らせ済み）

現在、設備の点検や安全対策に関する工事等を進めております。

女川原子力発電所の状況については、以下のとおりです。

### 1. 定期検査の実施状況

#### （1）女川原子力発電所1号機

女川原子力発電所1号機は、平成23年9月10日より第20回定期検査を実施しております。

平成28年1月31日現在、主な作業としてプロセス計算機更新工事等を行っております。

平成28年1月31日現在、主な作業としてプラント停止中の安全維持点検および耐震工事等を行っております。
